Sir,

I beg to state that One Dhananjoy Chatterjee (26) s/o. Banshidhar Chatterjee of Vill. Kuluchiha, P.O. & P.S. Chhatra, Dist. Bankura was a Security Guard of Anand Apartment, a housing complex, situated at 57 A & B, Padmapukur Road, Cal-20. Miss Hetal Parekh (18 yrs) w/o. Sri Nagardas Parekh was an inmate of Flat No. 3A of said housing complex. On 5.3.90 in the afternoon said Dhananjoy Chatterjee committed rape on Miss Hetal Parekh when she was alone in the said flat. After committing rape, accused Dhananjoy brutally killed Miss Hetal Parekh in the flat and at the time of decamping he took away some valuable articles. After committing such heinous crime culprit Dhananjoy remained absconded. After several raids accused Dhananjoy was arrested from his native village on 12.3.90. He is in Police custody till 25.5.90.

Post-Mortem Examination was over the deadbody of victim Hetal Parekh was held by you on 6.3.90 vide P.M.No. 232.

For the purpose of investigation of this case accused Dhananjoy Chatterjee is now required to be medically examined to substantiate the charge of rape against him. On prayer, Ld. S.D.J.M., Alipore, was pleased to permit his medical examination by your honour. Copy of relevant order sheet of Ld. S.D.J.M. Alipore is enclosed herewith for kind perusal.

I, therefore, pray that accused Dhananjoy Chatterjee may kindly be medically examined and your valuable opinion may kindly be given on the following points :-

- 1) whether he is capable of doing sexual intercourse,
- 2) whether he is capable of overpowering a girl like victim Hital Parekh with the intention of to commit rape on her, with reference to P.M. No; 232 dated 6. 3. 90.
- 3) Any other points of interest.

I also beg to submit that during investigation of this case blood, semen and pubic hairs were seized from the place of occurrence which have been sent to F. S. L. for examination. Above alamsats are appeared to be of aacd. Dhananjay Chatterjee. Now, pubic hairs, semen and blood of aacd. Dhananjay are required to tally with the those of seized pubic hairs, semen and blood by forensic Experts. Id. S. D J. M., Alipore was pleased to permit the collection of pubic hairs, blood and semen from a accused Dhananjay Chatterjee by your honour. Copy of relevent Order sheet is enclosed for kind perusal.

I therefore, <sup>pray</sup> ~~say~~ that public hairs, blood and semen of accused Dhananjay may kindly be collected and preserved by you, so that we can send the same to F. S. L. for examination.

- A. 2. The physique and general built of Dhananjoy Chatterjee is suggestive that he posses physical strength to singly overpower a girl of 18 years of age and built as was the case with the deceased Hetal Parekh (Vice P.M.No.232 dt. 6.3.90, Bhowanipore P.S. Case No. 87 dt.6.3.90)
- Q. 3. Any other point of Interest .
- A. 3. Blood in blotting paper, Citrate, EDTA and empty vial (for clotted blood) and Seminal fluid has been collected and preserved and handed over to the I.O. as ordered by Id. S.D.J.M., Alipore, 24-Parganas.
