This is to inform you that one Dhananjay Chatterjee (25) s/o. Bangshidhar Chatterjee of Vill. Kaludih, P.S. Chatra, District Bankura, was a Security guard of Anand Apartment at 57 A, B, Radmapukur Road, Bhowanipore, Calcutta-20. On 5.3.90 in the afternoon he committed rape on Miss Hetal Parekh (18y. 9) L/o. Sri Nagardas Parekh, inmate of Flat No.3A of said building and thereafter killed her brutally. At the time of decapitating he took away one ladies 'Ricoch' wrist watch from the said flat. After committing such heinous crime he went underground. Raid and Search was conducted in the native place of accd. Dhananjay Chatterjee with your assistance but to no effect.

I would request you to apprehend accd. Dhananjay Chatterjee and to recover the looted wrist watch, if found. If such Dhananjay Chatterjee is arrested he may be forwarded to Lt S.D.J.M. Alipore with an intimation to O/C. Bhowanipore P.S. Calcutta.
