## I. NATURE OF CRIME.

On 5.3.90 in the afternoon the mother of the victim girl Hetal Parekh L/o. Sri Nagardas Parekh of 57/A & B, Panna - pakur Road (Flat No. 3A) went out of their flat leaving her only daughter Hetal in the flat. At about 18.05 hrs. or so she returned home, found the door closed and none opened the door in on calls. The door was forced open and the victim girl Hetal was found lying in a pool of blood in their bed-room on the floor practically in naked condition. Her torn "Panty" having some hairs and stains was found lying on the floor near the entrance gate of the flat. There were some injuries on her person also. The Autopsy Surgeon opined the cause of her death was due to effects of smothering with strangulation ante-mortem and homicidal in nature. Some valuable articles had also been stolen from their flat. The victim girl was also raped. The Security Guard Dhananjay Chatterjee has absconded.
